# FILLMORE TOWNSHIP BOARD OF TRUSTEES JULY 8, 2008 7PM

#### 1. Call to Order.

Supervisor Keith Potter called the meeting to order at 7PM and opened with prayer.

#### 2. Roll Call.

All members were present.

# 3. Late Agenda Items.

Emergency access to I-96. Ottawa County Fair. 88<sup>th</sup> District Candidate.

#### 4. Graafschap Fire Department.

Captain Doug DenBleyker reported a total of 43 calls for service in June of which 12 were into Fillmore Township consisting of 6 fires and 6 rescues. Many of these calls coincided with the recent storms coming thru the area. He also reported a record 1324 meals were served at the annual July 4<sup>th</sup> Pancake Breakfast.

## 5. Fillmore Township Deputy.

Deputy Ron Haverdink reported a total of 46 calls for service in June.

## 6. Allegan County Commission.

No Report.

## 7. 88th State Representative District Candidates.

Shelly Edgerton and Jeff Farnsworth both candidates for the 88<sup>th</sup> State Representative District are seeking support in the August 5 Primary Election.

## 8. Allegan County Road Commission.

The Board has received bids for resurfacing  $139^{th}$  Ave. from Blue Star Hwy to  $60^{th}$  St. and  $54^{th}$  St. from  $138^{th}$  Ave. to  $141^{st}$  Ave. in the amount of \$224,811.10, plus county engineering/testing and distribution expense. After discussion a motion was brought by Keith Potter  $2^{nd}$  Chuck Schaap to not except the bid proposal for the following reasons:

- 1. 10% engineering/testing cost too high and open-ended.
- 2. 4.81% distribution cost also too high.
- 3. These costs should be handled as a flat rate per mile not as a percentage of contractor bid.

PASSED 5-0.

Supervisor Keith Potter will call the Allegan County Road Commission to determine possible alternative cost methods and the Board will re-visit these projects at a later date.

# 9. Allegan County Drains.

An application to establish a county drain has been submitted to the Allegan County Drain Commissioner. This drain would be located in Section 7 in Graafschap. Once a district has been established and the acquired signatures of property owners have been obtained the issue will be handled by the Allegan County Drain Commissioner.

#### 10. Fillmore Township Deputy Contract.

Keith Potter will be attending a meeting on July 23 where the Allegan County Sheriff's Department will be reviewing the contracts if has with Township contracting deputies.

# 11. Fillmore Township Water Sewer Contract Districts.

A contract with Holland Township for a shared line extension is being negotiated with Holland Township and the City of Holland. Final language with payment details will be approved at a later date.

Special assessment districts for the extension of Township water are being circulated. These districts are west on  $143^{rd}$  Ave. to Blue Star Hwy and also may include  $142^{nd}$  Ave. from  $56^{th}$  to  $58^{th}$  St. and west on  $142^{nd}$  to the Country Acres mobile home park.

A motion was brought by Kenneth DeWeerdt  $2^{nd}$  John Kleinheksel to approve the Election Committee's appointments. PASSED 5-0.

### 13. Emergency Access.

A meeting has been scheduled for information on Graafschap Fire for an Emergency Access to I-96 on September 23, 2008. This access would greatly enhance response times to calls on the I-96 expressway.

#### 14. Cemeteries.

Due to recent storm damage to trees at the East Holland Cemetery a motion was brought by Keith Potter 2<sup>nd</sup> Chuck Schaap to hire E.Jay Schaap and Dan Schaap for clean-up and brush hogging long this drive for a total of \$500.00. PASSED 5-0.

#### 15. Fillmore Township Board Minutes.

A motion was brought by John Kleinheksel  $2^{nd}$  Janella Hop to approve the June 10, 2008 Board minutes as presented.

PASSED 5-0.

## 16. Monthly Bills.

A motion was brought by Kenneth DeWeerdt 2<sup>nd</sup> John Kleinheksel to pay the submitted bills.
