(b) The public records made available contained the information being sought in the prior written request and are still in the township's possession. (c) The public records were made available to the individual, subject to payment, within the best effort

(d) Ninety (90) days have passed since the township notified the individual in writing that the public records were available for pickup or mailing.
