4. Graafschap Fire Department.

Fire Chief Cal Haverdink reported 31 calls in January, 1 fire and 3 rescues were in Fillmore Township.

John Kleinheksel reported that an off-road vehicle and equipment for it has been purchased with 2008-2009 funds. The 2009-2010 fire department proposed budget was presented. Total expenditures will be \$427,655.00; Fillmore Township 19.55% will amount to \$83,607.00. Capital out lay includes new turnout gear for the entire department.
