4. Graafschap Fire Department.

Fire Chief Cal Haverdink reported 34 calls for service in August. There was 1 fire call and 8 rescue calls into Fillmore Township.

Emergency Access to I-196 is in the engineering design phase. Construction of this access is planned for 2016 in conjunction with southbound I-196.

Chief Haverdink stated that the new narrow band equipment for the County 911 system has been purchased.

7. Holland Board of Public Works Electric Franchise.

Agreement to mirror that of the other Townships serviced by the B.P.W., benefits due Township if any other local unit of government receives such benefit, or anything built within the Township for electrical production, also a south side representative to the ExOfficio member to the H.B.P.W. Board.
