There are 2 options under consideration:

- 1. The Bouwman family to put in the line and be reimbursed from future hook-ups for service.
- 2. A Special Assessment District would be created.

The cost of this ½ mile is approximately \$400,000.

At this time the Township is waiting for notification from the Bouwman Family as to how they wish to proceed.
