1. Call to Order.

4. Graafschap Fire Department.

Fire Chief Cal Haverdink reported a total of 43 calls for July 2013. There were 2 fire calls and 9 rescue calls for Fillmore Township.

5. Allegan County Commission.

Jim Storey reported:

- a. Update on the new Allegan County Jail heavy construction done by September or October 2013. A Transition Consult is being hired to facilitate the move of inmates in January 2014, also staffing and transporting of prisoners to the jail following pre-trial hearings. Pre-trial hearings hopefully to be done via video conferences, this has the potential to be a savings of approximately 3 million dollars.
- b. The Economic Development Commission is looking to hire a part time coordinator to work with 3 other entities to ensure that Allegan County is given coverage.
