1. Call to Order.

4. Graafschap Fire Department.

Fire Chief Cal Haverdink reported a total of 36 calls for September 2014. There was 1 fire call and 6 rescue calls for Fillmore Township, also 2 fire assist to Saugatuck Township Fire District and 1 fire assist to Hamilton Fire Department.

5. Allegan County Commissioner.

- b. The annual report from the Allegan County Road Commission shows snow removal costs to be higher than the past 10 years.

- d. D.N.R. would like to add 200 acres to the game preserve bringing this to a total of 58,000 acres.
- e. 3 County leaders are now in State wide leadership.
- f. Allegan County will again be receiving reimbursement from prisoners held in the jail.
