6. Allegan County Commissioner.

Jim Storey reported:

- a. The Allegan County Clerk's office was hopeful of achieving a solution for uploading election results in a timely manner following elections.
- b. The Westside Park in Ganges is being completed with a D.N.R. Grant and Allegan County matching funds.
- c. 911 is requesting a design for a new radio system.
- d. A Livestock Claim Policy should be available at the June Board meeting.

9. May 5, 2015 Special Election.

11. Fillmore Township Planning Commission.

Chuck Schaap reported that the Land Use Plan will be looked at during the upcoming May 18, 2015 Planning Commission meeting.

12. Supervisor Updates.

 A meeting was held regarding the Blue Star Utilities, completed petitions for Sewer and Water will be coming to the Township Board, with the Board then to decide on the project.

Hearings on the project would be early Fall of 2015. Bids for this project are expected to be up 20% from 2014.

- c. Township resident Brad Iverson will serve as the Fillmore Township representative on a Broadband Committee.

- e. Fillmore Township Roads:
 - 1. A bid of \$17,700.00 has been received for the gravel.
 - 2. Re-paving of 1.75 miles a bid of \$178,367.00.
 - 3. Chip seal of 2.8 miles no bid has been received, possibly \$28,000/mile has been proposed.

Commissioner John Kleinheksel reported the building project is going well; the garage is 4-6 weeks away from completion. New offices will be started following the demolition of the old buildings.
