## b. GHP Site Plan:

Upon recommendation from the Fillmore Township Planning Commission:

Ron and Jayne Hamberg presented a parcel split survey and Site Plan for GHP Systems, Inc., the proposed structure addition and parking lot is at approximately 4272 Blue Star Hwy, Parcel #0306-018-015-00. Ron stated that he recently purchased and split the C-2 property and is proposing a building addition and parking area on parcel B which is 2.825 acres. The current structure will be converted to office use and the new construction will be used to continue their Geo-Thermal heating and cooling business which currently employs 3. Water will be obtained from an on-site well and they will be connecting to the municipal sewer system.

The Site Plan presented was of excellent quality and detail.
