1. Call to Order.

Supervisor Ken DeWeerdt called the meeting to order at 7pm, opened with prayer and led in the Pledge of Allegiance.

4. Graafschap Fire Department.

Fire Chief Doug DenBleyker reported;

- A total of 53 calls for January 2017. There were 2 fire calls and 8 medical calls for Fillmore Township, also 4 calls to other Departments, 3 assists to Saugatuck Fire District and 1 assist to Holland City Fire Department. Office Staff to be hired, this is a full time position with benefits.
 - The Fire Station loan to be paid in full May 2017
- b. Fire Board Chairman Bob Yonker presented the 2017-2018 Budget;
 A Motion was brought by Bob Yonker and 2nd by Chuck Schaap to approve the proposed budget for the Graafschap Fire Department. Fillmore Township's share is 19.07% or \$102,326.00 of that Budget, this being a combination of calls and S.E.V. from Fillmore Township.

Fire Chief David Haverdink reported;

- a. Present the annual report for 2016 and the 2017-2018 Budget. The Department responded to a total for 379 incidents for 2016 which is a 19% increase from 2015.
 - A Motion was brought by Chuck Schaap and 2nd by Janella Hop to approve the proposed budget for the Hamilton Fire Department. Fillmore Township's share to be \$59,467.20 which is 13% of their budget.
 - PASSED 5-0.
- b. A table top exercise will be held in March 2017 with a full drill in April 2017. These drills pertain to a Mass Violent Incident.
