1. Call to Order.

Supervisor Ken DeWeerdt call the meeting to order, opened with prayer and led in the Pledge of Allegiance.

2. Roll Call.

Members Present: Ken DeWeerdt, Leah Folkert, Chuck Schaap, Bob Yonker and Elaine Mokma. Members Absent: None.

3. Late Agenda Items.

- a. Fillmore Township Property-Chuck Schaap
 - 1. New Roof
 - Motion light for entry doors.

4. Graafschap Fire Department.

Fire Chief Doug DenBleyker reported;

- a. A total of 47 calls for October 2017. There being 3 fire calls, 11 medical/rescue, also 3 fire call to other departments or agencies.
- b. November 1, 2017 the new Engine 712 went into service.
- c. November 8, 2017 M.A.C.C. held a Service Delivery meeting inviting area Fire Chiefs and Township and City officials to discuss community cooperation for fire department mutual aid, staffing, recruitment and retention of personnel.

5. Allegan County Commissioner.

Jim Storey reported;

- a. At a recent meeting of the Board of Commissioners an Indigent Defense Plan was adopted. Allegan County hopes to work with VanBuren County in this Plan. Currently Allegan County awaits funding from the State of Michigan for this Plan.
- b. Allegan county Health Department has added Sanitarians to their staff enabling inspections to be done in a timely manner.
