4. Graafschap Fire Department.

Fire Chief Doug DenBleyker reported;

- a. A total of 74 calls for November 2020. There were 8 medical calls and 4 fire calls for Fillmore Township, there were 6 fire calls and 2 medical calls to other agencies.
- b. A Grant was received from Wolverine Pipeline, these monies will be used for a new Thermal Imaging Camera.
