1. Call to Order.

Supervisor Ken DeWeerdts call the meeting to order, Chuck Schaap with prayer and led in the Pledge of Allegiance.

2. Roll Call.

Members Present: Ken DeWeerdts, Elaine Mokma, Leah Folkert, Bob Yonker and Chuck Schaap.

Members Absent: None.

3. Late Agenda Items.

None.

4. Graafschap Fire Department.

Fire Chief Doug DenBleyker reported;

a. A total of 75 calls for September 2020. There were 6 fire calls and 13 medical calls for Fillmore Township, there were 8 fire calls and 2 medical calls to other agencies.

5. Fillmore/Overisel Township Deputy.

Officer Tyler Langerak reported;

a. 82 calls for September 2020, 41 calls for Fillmore Township and 41 calls for Overisel Township.

6. Allegan County Commissioner.

Jim Storey reported;

a. The Board of Commissioners passed the January 2021 Budget with a slight increase.

b. The Board of Commissioners have approved a new entrance for the County Building. This entrance will include a Sally Port. Completion expected for the Summer of 2021.

c. The demolition process of the Rock Tenn Paper Mill will begin soon.

d. Circuit Court Proceedings will soon be available on U-Tube.

11. Fillmore Township Planning Commission.

Chuck Schaap Planning Commission member gave a report of the recent September 21, 2020 meeting;

- a. A Rezoning Hearing was held at the request of Mary Hofmeyer to rezone 3 parcels for a total of 14 acres, Parcel #0306-011-013-20, 0306-011-014-00 and #0306-011-013-20 from A-1 to A-2.

A Motion was brought by Chuck Schaap and 2nd by Leah Folkert to accept this recommendation for the above rezoning 3 parcels as presented by the Planning Commission.

- b. A Site Plan was presented by Jack Love for property located at 143rd Ave. west off M-40, Parcel #0306-015-007-01.

A Motion was brought by Ken DeWeerd and 2nd by Elaine Mokma table this Site Plan request until complete plans are presented.

PASSED 5-0.

- c. November 16, 2020 the Planning Commission will hold a Public Hearing for a Site Plan for an expansion of Village Self Storage.

12. Supervisor Updates.

- a. 52nd Street Sewer is not completed. No bills have been received.

- b. 52nd St. Expansion which would add 600 ft to 147th Ave. A meeting will be held on October 16, 2020 to further discuss this project and look at bids.

- c. East Saugatuck Cemetery.
Sexton Howard Lubbers has proposed a driveway improvement in the cemetery. This would include grading and crushed concrete.

A Motion was brought by Chuck Schaap and 2nd by Bob Yonker to approve this improvement with spending of no more than \$5,000.00.

PASSED 5-0.

- d. October 24, 2020 a Township Clean-up day is planned. This is for Township residents only and a fee will be charged.

- e. 54th St. Culvert repair and replacement has been completed.

- f. A Snow Removal Quote has been received from Haverdink Enterprises, Inc for the 2020-2021 winter season. This covers the Township Offices, Water Tower and Pump House.

A Motion was brought by Elaine Mokma and 2nd by Leah Folkert to accept these quotes, sign the contract as presented.

- g. Fillmore Township Board of Appeals met on September 28, 2020 to consider a Variance request of Whitney Draisma-Hirdes to construct an accessory building with set-backs less than the Fillmore Township Zoning Ordinance allows. This Variance request was allowed by the Board of Appeals. Minutes are included as information.

- h. A 3rd quarter report was received as information from the ODC Network.
