1. Call to Order.

a. Supervisor DeWeerdt - Remarks

4. Allegan County Commissioner.

Jim Storey was absent with notice. He sent a report which the Board took as information.

5. Fillmore/Overisel Deputy.

Officer Dillon Schmitt submitted the following report;

a. There were 78 calls for January 2023, 56 calls for Fillmore Township and 22 for Overisel Township.
